LETTER OF ASSURANCE FOR SALE OF GOODS

This Letter/Agreement is made on 10th September 2025 for **EXIM PRO GROUP**, having its registered office at Gat No. 4780/15, Plot No. 9, Tiranga Nagar, Isbavi, Pandharpur, Solapur, Maharashtra – 413304, hereinafter referred to as the Seller (Exporter). Whereas the Seller is a merchant exporter of Agro-Commodities, Fresh Fruits, and Vegetables. The Seller undertakes to sell, and the Buyer undertakes to buy from the Seller. EXIM PRO GROUP, with GST Number/Code: 27CIVPS2918E1ZQ and IEC Number/Code: CIVPS2918E, has been fully verified along with all other relevant details.

We are pleased to provide this assurance regarding the total amount for the current transaction, in accordance with our mutual agreement.

TERMS & CONDITIONS:-

- The Seller is a merchant exporter of agro-commodities and fresh fruits and vegetables, each category or product (hereinafter referred to as the "said goods"), at the rate mutually decided by the Buyer and Seller.
- The Buyer hereby agrees to purchase 50 MT of pomegranates from the Seller for a total consideration of USD 192,556.
- It is agreed that the Buyer will make an advance payment of 70% of the proforma invoice amount.
- It is agreed that upon receipt of the advance payment, the Seller (Exporter) will commence production.
- It shall be the responsibility of the Seller to initiate shipment of the exact order value within 120 days from the date of receipt of the advance.
- The shipping terms (Incoterms) will be FOB, with the Seller responsible for delivering the goods to the port of loading in India. Beyond that point, all liabilities and logistics will be handled by the Buyer.
- Before initiating the dispatch process, the Seller requires the remaining 30% payment. Once this payment is received, the Seller will proceed with dispatch.
- It has been agreed that after receipt of the full invoice amount, the Seller will complete all customs clearance formalities in India as required prior to the export of the said goods at the port of loading.
- The Buyer shall arrange transportation and delivery of the said goods to the final destination at his own cost.
- It shall be the responsibility of the Buyer to insure the said goods for their full value at his own cost.
- If any export-related formalities are required to be completed from the place of dispatch, the same shall be completed by the Buyer at his own cost, and the Seller will provide assistance if requested by the Buyer.

QUALITY & OTHER COMPLIANCE:-

- The Seller guarantees that all goods supplied conform to mutually agreed specifications, quality standards, and are compliant with applicable laws and export regulations.
- Goods once sold will not be taken back or exchanged under any circumstances.
- No Return, No Cancellation, No Refund.
- This Agreement/Letter also includes the official bank account details of the Seller for the purpose of all related payments under this transaction.
- The Seller shall not be responsible for delays or charges incurred due to incorrect payment details provided by the Buyer.
